SRTMU Nanded.

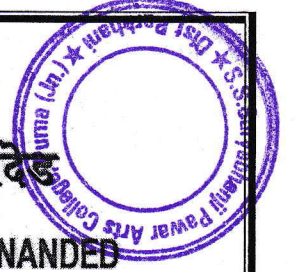
