A Hospital means any institution established for in-patient care and day care treatment of illness and/or injuries and which h A mospical means any institution escapisated for in-patient care and day care treatment or liness and/or injuries and which it registered as a Hospital with the local authorities under the Clinical establishments (Replation and Augustion) Act, 2010 or the enactments specified under the Schedule of Section 56(1) of the said Act OR compiles with all minimum criteria as under
